Introduction

The Acadiana Metropolitan Planning Organization (AMPO) is housed under the Acadiana Planning Commission (APC) and is the regional planning body for the Acadiana area. MPOs are designated for census defined urbanized areas with a population greater than 50K. MPOs that have a population greater than 200,000 residents are designated as a Transportation Management Areas (TMA). MPOs are tasked with certain core functions related to transportation planning as per the Code of Federal Regulations via the federal reauthorization of transportation funding through the Infrastructure Investment and Jobs Act. MPOs are required to maintain a Long-Range Transportation Plan with a 20-year horizon, a Congestion Management Process (CMP) and a Transportation Improvement Program (TIP), a 4-year short term allocation of federal, state, and local transportation funding. The allocation of transportation funding is based off a formula derived from the MPO area's population. This funding, along with all federal transportation funding allocated in the Metropolitan Planning Area (MPA), should be expended on projects and endeavors that support the AMPO's goals and objectives as laid out by the Metropolitan Transportation Plan.

Purpose of the Annual List of Obligated Projects

The annual list of obligated projects provides public information regarding the obligation of federal transportation funds in the Metropolitan Planning Area. The Code of Federal Regulations states the following:

§450.334 Annual listing of obligated projects.

- (a) In metropolitan planning areas, on an annual basis, no later than 90 calendar days following the end of the program year, the State, public transportation operator(s), and the MPO shall cooperatively develop a listing of projects (including investments in pedestrian walkways and bicycle transportation facilities) for which funds under 23 U.S.C. or 49 U.S.C. Chapter 53 were obligated in the preceding program year.*

Through cooperation with the DOTD, FHWA, and the Lafayette Transit System (LTS), a list of projects is derived annually which shows the types of Federal funds that have been obligated throughout the MPA for the previous Federal Fiscal Year (October 1st thru September 30th). This list details information such as project names, amount of funding spent, date on which the funding was spent, and other relevant information for the public and decision makers on transportation transactions in the MPA. Transit funding lists are derived from funding approved for expenditure in the previous fiscal year.

Division of Project Tables

Projects have been divided into four categories: projects sponsored by DOTD, MPO projects sponsored by Local Public Agencies, Local Road Safety projects sponsored by Local Public Agencies, and other federal funding projects sponsored by Local Public Agencies. The MPO's funding that is directly controlled by the Policy Board is the STP>200k (a suballocation from DOTD of FHWA's Surface Transportation Block Grant program).

Justice 40 Analysis

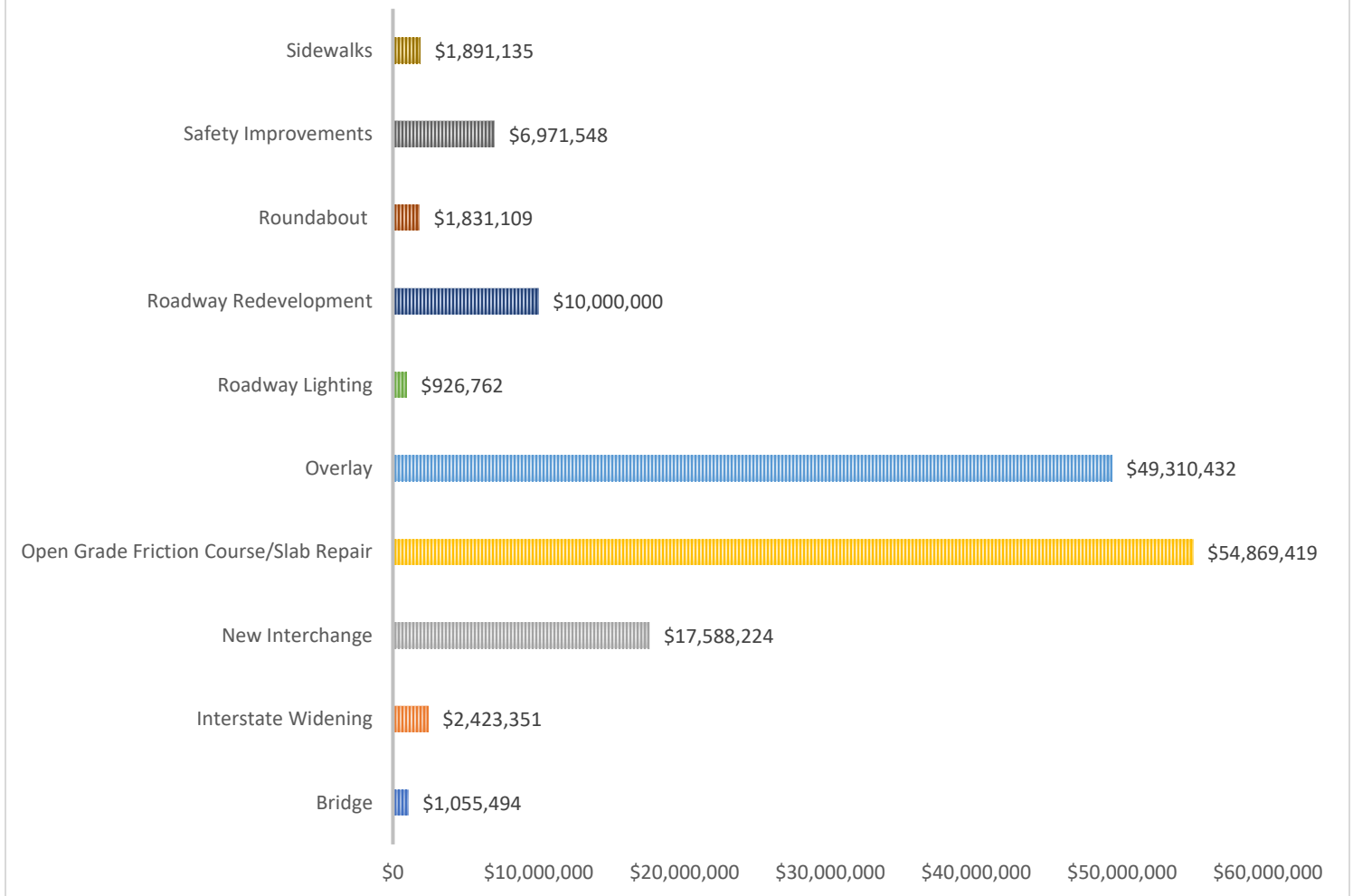
Through the Justice 40 initiative created by Executive Order 14008, the Federal Government has made it a goal that 40 percent of the overall benefits of Federal investments flow to disadvantaged communities that are marginalized, underserved, and overburdened by pollution. To reach this goal, the US DOT has developed a tool for analyzing project locations to identify if they are providing benefits to disadvantaged communities. MPO staff used geospatial analysis tools to review the federal investments in Acadiana to gauge if DOTD and the MPO are reaching this goal. Of the federal funds expended in 2022, 51% were in or on the boundary in Census Tract that is designated as US DOT Transportation Disadvantaged Community. Of the Acadiana MPO's funding that is directly controlled by the Policy Board (STP>200K), 93% of funds were expended in a designated Disadvantaged Community.

Summary

In Federal Fiscal Year 2022, approximately \$148,532,031 of funding on 67 projects was obligated in the Acadiana Metropolitan Planning Area. This represents an increase of 45% increase in transportation funding for the area when compared to 2021's \$67,927,838 in federal investment. The highest value project was H.012174: I-10: JEFF DAV PL-I-49 (OGFC/SLAB REPAIR) at \$55 million dollars, followed by the H.013265: US 90: LA 14 - LA 83 at \$24 million dollars. The Acadiana MPO's federal funding allocations are designated in the program as STP>200K Funding Source. In Federal Fiscal Year 2022, a total of \$12,132,568 was obligated under this program for the Acadiana MPO area, with LA DOTD providing additional expenditures of State Cash at \$3,198,138. The primary projects receiving obligated funding under the program are the LA 353: LA 94 TO CYPRESS ISLAND HWY project, the CYPRESS ISLAND HWY PAVEMENT PRESERVATION project, and LA31:0.899 MI S LA92-0.15 MI N OF N LA96 project in St. Martin Parish, and the US 167: ACCESS MANGEMENT (LFT TURN LNS) roadway lighting project in Lafayette Parish, and S LEWIS ST WIDENING in Iberia Parish.

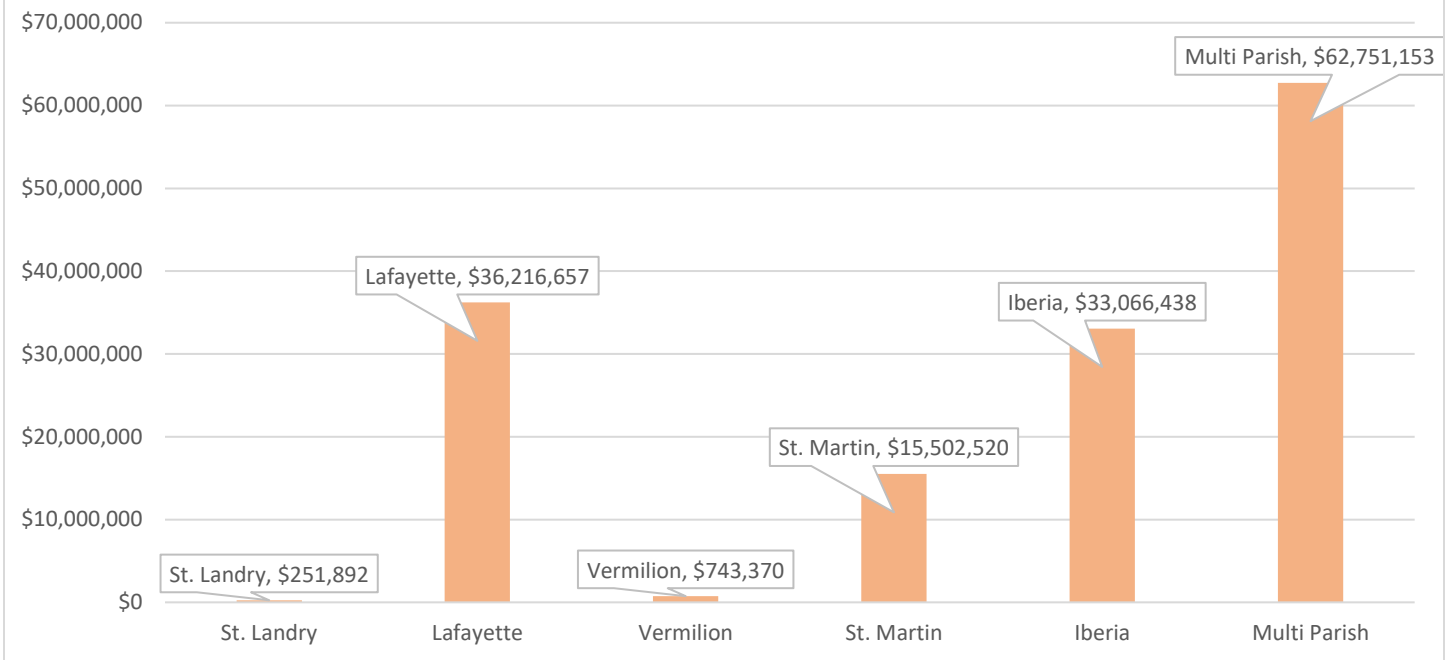
Approximately \$3,647,561dollars were obligated on transit funding in Federal Fiscal Year 2022 in the form of Urbanized Area Formula Grants (5307) and Buses and Bus Facilities Formula Grant (5339) Act funding. The primary recipient of the funds was Lafayette Transit System, the only fixed route operator in the MPO area.
