## Introduction

The Acadiana Metropolitan Planning Organization (AMPO) is housed under the Acadiana Planning Commission (APC) and is the regional planning body for the Acadiana area. MPO are designated for census defined urbanized areas with a population greater than 50K. MPOs that have a population greater than 200,000 residents are designated as a Transportation Management Areas (TMA). MPOs are tasked with certain core functions related to transportation planning as per the Code of Federal Regulations via the federal reauthorization of transportation funding through the FAST Act. MPOs are required to maintain a Long-Range Transportation Plan with a 20-year horizon, a Congestion Management Process (CMP) and a Transportation Improvement Program (TIP), a 4-year short term allocation of federal, state, and local transportation funding. The allocation of transportation funding is based off a formula derived from the MPO area's population. This funding, along with all federal transportation funding allocated in the Metropolitan Planning Area (MPA), should be expended on projects and endeavors that support the AMPO's goals and objectives as laid out by the Metropolitan Transportation Plan.

## Purpose of the Annual List of Obligated Projects

The annual list of obligated projects provides public information regarding the obligation of federal transportation funds in the Metropolitan Planning Area. The Code of Federal Regulations states the following:

*§450.334 Annual listing of obligated projects.*

- (a) In metropolitan planning areas, on an annual basis, no later than 90 calendar days following the end of the program year, the State, public transportation operator(s), and the MPO shall cooperatively develop a listing of projects (including investments in pedestrian walkways and bicycle transportation facilities) for which funds under 23 U.S.C. or 49 U.S.C. Chapter 53 were obligated in the preceding program year.*

Through cooperation with the DOTD, FHWA, and the Lafayette Transit System (LTS), a list of projects is derived annually which shows the types of Federal funds that have been obligated throughout the MPA for the previous Federal Fiscal Year (October 1<sup>st</sup> thru September 31<sup>st</sup>). This list details information such as project names, amount of funding spent, date on which the funding was spent, and other relevant information for the public and decision makers on transportation transactions in the MPA. Transit funding lists are derived from funding approved for expenditure in the previous fiscal year.

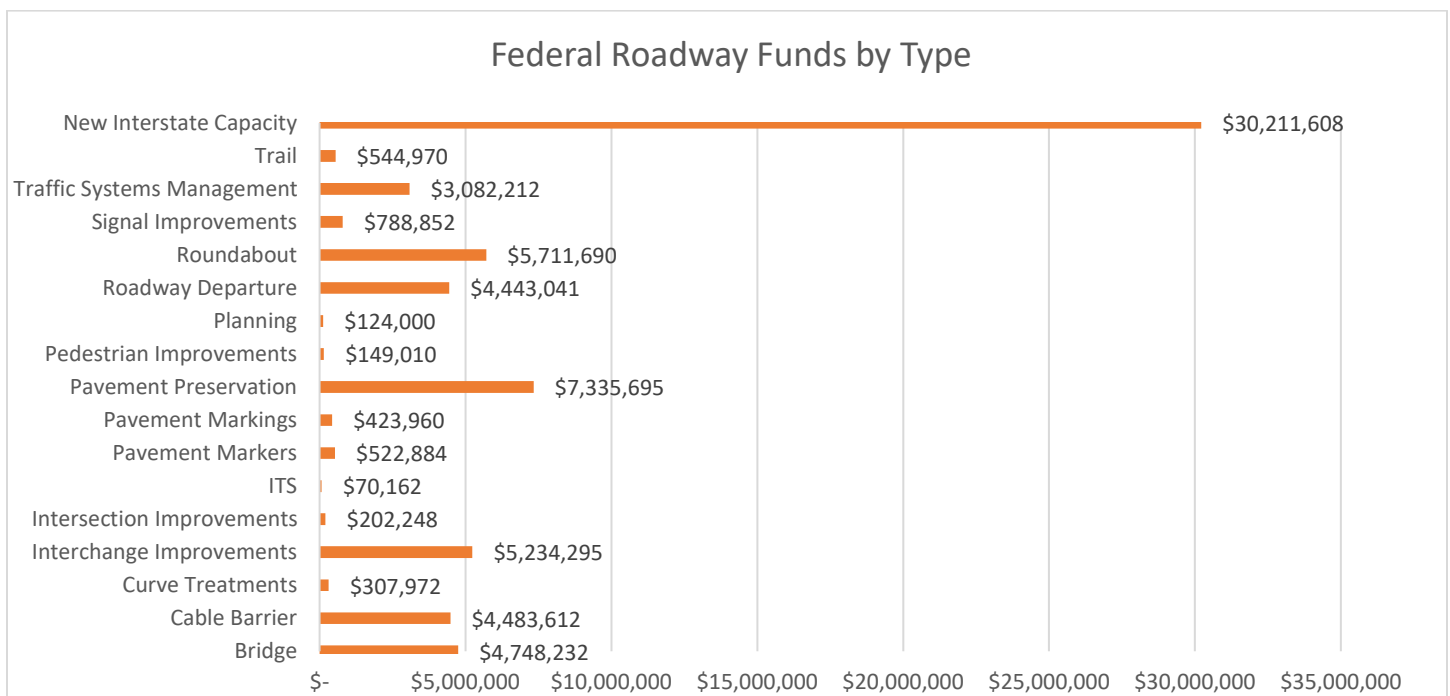

## Summary

In Federal Fiscal Year 2021, approximately \$67,927,838 of funding on 73 projects was obligated in the Acadiana Metropolitan Planning Area. The highest value project was H.003003: I-10 Widening: East Junction of I-49 TO LA 328 at \$27 million dollars, followed by the H.010601: I-49 INTERCH:LA726/LA98/PONT DES MOUTON. The Acadiana MPO's federal funding allocations are designated in the program as STP>200K Funding Source. In Federal Fiscal Year 2021, a total of \$7,930,039.75 was obligated under this program for the Acadiana MPO area. The primary projects receiving obligated funding under the program are the US 90: Cameron Street Overlay project and the St. Mary Sidewalk project in the City of Scott, the Cypress Island Highway Pavement Preservation project in St. Martin Parish, and the LA 92: Pavement Preservation project in Vermilion Parish. The chart below indicates total federal obligations for 2021 by parish.

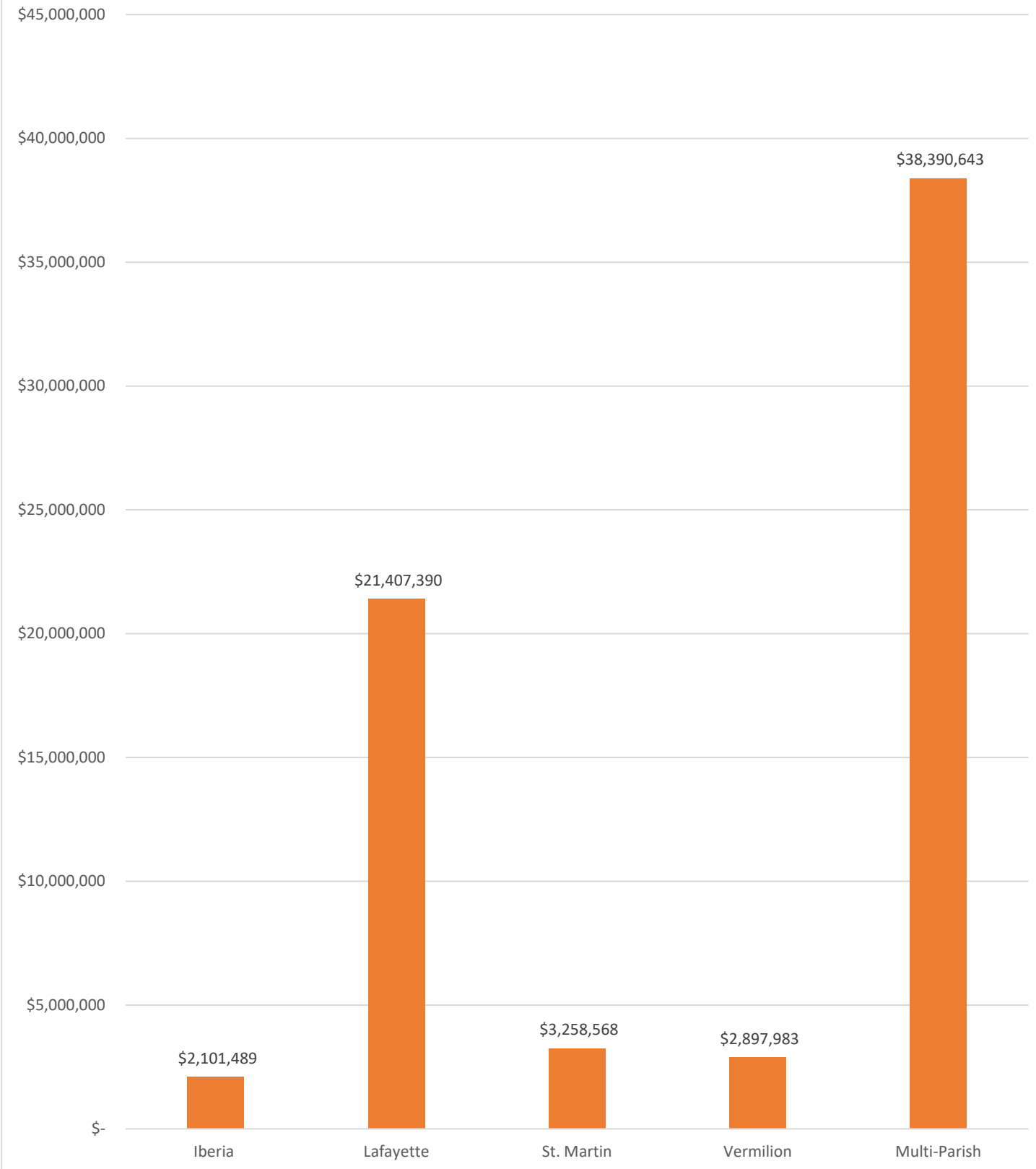
Approximately dollars \$4,274,261 was obligated on transit funding in Federal Fiscal Year 2021 in the form of Urbanized Area Formula Grants (5307), Buses and Bus Facilities Formula Grant (5339), Public Transit Human Services (5310) and CARES Act funding. The primary recipient of the funds was Lafayette Transit System, the only fixed route operator in the MPO area.

As part of the MPO's goal to create a safe transportation system for all users, MPO staff has provided technical assistance to local public agencies in the development of Safe Routes to Public Places and Local Road projects. The Acadiana Regional Transportation Safety Coalition, managed by the MPO, also coordinates with DOTD District 03 to develop Highway Safety Improvement Program projects. Several of the projects in development received federal funding allocations in 2020-2021:
