UPWP Purpose

The Unified Planning Work Program (UPWP) is a contractual document that describes the coordinated transportation-planning program to be undertaken within the Acadiana Metro Planning Area. These planning activities are the function of the Acadiana Metropolitan Planning Organization (AMPO).

Under Federal planning guidelines, the MPO is required to submit a work program that highlights transportation planning projects into broadly categorized planning activities and documents the funding for each activity for a fiscal year. This is done through the Unified Planning Work Program. The funding is provided through the State of Louisiana (LaDOTD) from the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA). FHWA funds are provided at an 80/20 match ratio, with 80% of the total funds provided by Federal funds and 20% provided by local member entities, with the exception of the Complete Streets Planning task that can be funded at 100% federal funds. The FTA funds are provided at an 80/20 ratio with 80% being Federal and 20% provided by local member entities.

The financial support for these planning activities is provided by the Federal Highway Administration, the Federal Transit Administration, the Louisiana Department of Transportation and Development, and member entities of the Acadiana MPO. The Acadiana MPO member entities include Acadia Parish, Iberia Parish, Lafayette Parish, St. Landry Parish, St. Martin Parish, Vermilion Parish, and the Cities of Carencro, Scott, Broussard, Abbeville, St. Martinville, New Iberia, Youngsville, Lafayette, and Breaux Bridge. One of the key components of preparing the UPWP is actively cooperating and assisting with local planning. The development and implementation of the Unified Planning Work Program is required under federal law (23 CFR 450.308 (c)) for urbanized areas with populations greater than 50,000.

The 2010 Census expanded the Urbanized Area for the Acadiana MPO and in October of 2012 the Acadiana MPO was designated as a Transportation Management Area (TMA). The 2020 Census retained the Acadiana MPO as a TMA, and the MPO expanded the boundary to include the City of Abbeville and partially the City of Rayne. The MPO has been hosted by the Acadiana Planning Commission since 2015, which serves the parishes of the Acadiana region.

The Acadiana MPO will continue to promote regional coordination by participating in local, regional and state organizations. These include but are not limited to the Louisiana Planning Council, Louisiana Department of Transportation and Development, Federal Highways Administration, Federal Transit Administration, the cities of Abbeville, Breaux Bridge, Broussard, Carencro, New Iberia, Lafayette, Scott, St. Martinville, and Youngsville, the parishes of Lafayette, Acadia, Iberia, St. Martin, St. Landry and Vermilion, and other agencies that discuss transportation issues.

Acadiana's Planning Priorities

The MPO's priorities for the 2026-2027 fiscal year include the daily management operations of the Metropolitan Planning Organization. The most significant priority is the development of the new Metropolitan Transportation Plan for the region, scheduled for adoption in 2027. This will include a significant model update, primarily the integration of data collected during the 2020 Census. Another major priority will be working with the member local public agencies to ensure timely delivery of MPO projects.

The MPO also manages the transportation model for the region and regularly updates it and provides model runs for member entities and DOTD to evaluate the impact of potential projects. For data, the MPO queries, collects, updates, and maintains a robust collection of roadway data essential to the transportation decision making process, including roadway location and asset data, crash data, land use data, and traffic data.

On the Transit side, the MPO coordinates operations and improvements with the fixed route transit operator Lafayette Transit System and Human Services transit operators to ensure that Acadiana residents have access to multimodal options for transportation access. This includes facilitating transit expansion to the Acadiana region. The MPO is also incorporating the Human Services Transit Providers Coordinating Committee into the process of consultation with MPO plans and processes.

For 2026-2027, additional priorities will be integrating any new priorities and planning objectives from the transportation reauthorization bill that is scheduled for adoption in October of 2026. The MPO will also coordinate with DOTD as the department continues its reorganization process.

Planning Challenges

Challenges facing the Acadiana MPO area for 2026-2027 will be improving project delivery timelines and facilitating local public agency projects through the DOTD process. The DOTD process and slow review times, contract services coordination, and delays along the project stages continue to be a major impediment for timely project delivery and impair the utilization of STP>200K funding for local infrastructure projects. This process delayed construction of many of the MPO's projects in 2025, putting future project timelines at risk due to limits on the amount of federal funds that is available to obligate in a fiscal year. DOTD's reorganization efforts should hopefully improve this process and facilitate the delivery timelines. Inflation also remains a major impediment to project delivery.

Inflation continues to limit the funding available for individual projects each year, pushing projects that are ready for construction back due to the obligation limit. The MPO will continue to monitor construction costs closely to ensure that project costs are regularly evaluated and updated on the TIP.

PURPOSE:
