LA WATERSHED INITITATIVE	Brad Spiegel of LA OCD announced the following update:
UPDATES	<u>Working with Nature Training Series</u> – LWI hosted the first Working with Nature Training series webinar with an introduction to working with nature and the Vermilion River case study on Oct. 20, 2021. A recording is available at https://vimeo.com/637983578. The second module in the series will be hosted on November 17, 2021.
REGIONAL	The Governor's office is now working on a draft legislative package. They are using the
ENABLING	regional recommendations presented to the Council on Watershed Management on
LEGISLATION	August 5 th . The package will contain the regional and statewide framework (regions under the state). This framework will be turned into a draft legislative bill. The Council is working under the Governor's Executive Order to make coordinated watershed management long term. A draft legislative package (bill) is expected by the end of 2021 or early 2022. Once the Governor approves the draft, the Watershed Coordinators can provide information that is in the bill to Committee Members.
	Legislative Outreach Event: Collaborative/Trans-Regional Legislative Round Table in January - Region 5 held a legislative round table event in April. There is a goal to host another in January before the legislative session, but this time, APC would like to work with the surrounding regions to have a combined round table event (e.g., Regions 4, 5, & 6).
